22	This matter came on for trial on July 15, 2019 in Dept. C-34 of the Orange County	
23	Superior Court, Judge Frederick Horn presiding.

25	of Plaintiffs and Defendant the Court finds as follows:	
	That the promissory notes issued by Defendant Monarch Capital Investment Fund,	
26	LLC are securities, and Defendant Timothy Peabody is a control person pursuant to	
27	Corporations Code §§ 25019 and 25504, respectively;

That Defendant Monarch Capital Investment Fund, LLC sold unqualified, non exempt securities to Plaintiffs in violation of Corporations Code §§ 25110 and 25503;

That Defendants Monarch Capital Investment Fund, LLC and Monarch Capital Investment Group, LLC having otherwise failed to appear or defend in this matter, and their defaults having been entered by the clerk on May 9, 2019; that based upon Plaintiffs' motion for default judgment, and the evidence received at trial, default judgment shall issue against them.

Wherefore Plaintiffs Robin and Troy Suntheimer ("Plaintiffs") shall have judgment against Defendant Timothy Peabody in the amount of \$102,960; and separately, Plaintiffs shall have judgment against Defendants Monarch Capital Investment Fund, LLC and Monarch Capital Investment Group, LLC in the amount of \$238,819.

This judgment shall bear interest at the legal rate.
